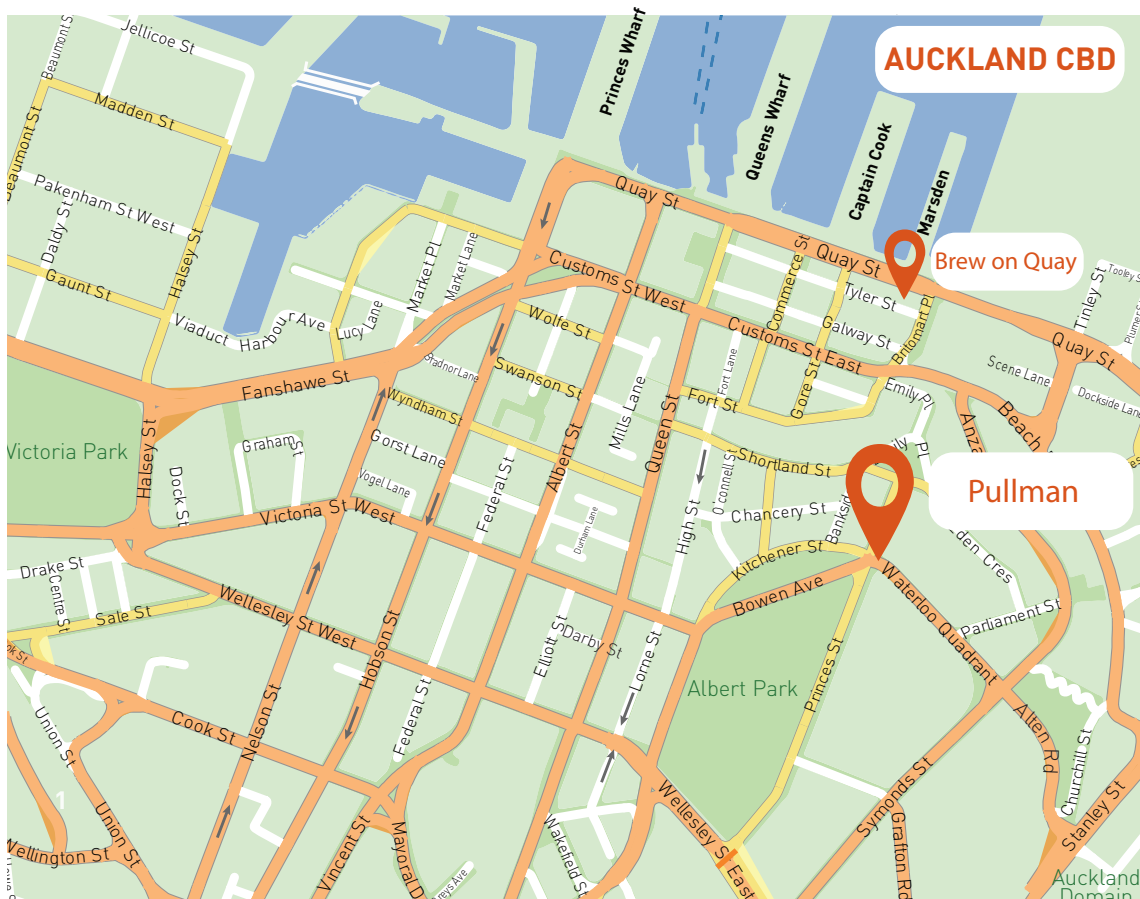

Andrew has previously served 5 years in financial services, 2.5 of which with National Australia Bank and the subsidiary Bank of New Zealand. He is currently working in the FX team at BNZ and is still active as a television commentator and rugby pundit.

Steve is a qualified Midwife, whose career includes senior nursing roles in London and Papua New Guinea. Her community achievements include establishing the first family planning clinic in Rotorua, helping to

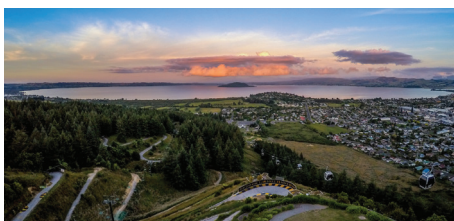
