FORT WORTH



DAY 2, TUESDAY 17 OCTOBER

FORT WORTH

Today our delegates will hit the ground running, with our energy delegates visiting BNSF Railway which has connected 400 different railroad lines over the course of 170 years. Our agricultural delegates will learn the practices behind sustainable food systems and how Cargill Meat Solutions connect farmers with markets and customers with ingredients, to empower the US agricultural industry.

Delegates will enjoy a presentations from key industry speakers followed by a lavish lunch at Reata's dome overlooking the city of Fort Worth. Delegates will have the opportunity to visit the NASA Space Center and shopping in The Galleria, ending the day with our farewell group dinner.





Resort Fee

MINIMUM NUMBERS: The Tour is subject to and conditional on a minimum number of full paying passengers booking and **paying their booking fees in full by August 31** as stated by TSBE. If the required numbers are not reached by that date, the Tour may be cancelled, postposed, changed and prices are subject to change.

RESERVATIONS AND PAYMENT: Please book your spot on the Tour as early as possible. To secure your spot on the Tour, you must pay the full fees within 7 days after TSBE invoices you. Please note if you fail to pay the invoiced amount within 7 days of the invoice date, TBSE reserves the right to, and may, reject your booking and resell your spot to someone else. It is the responsibly of the delegate making the booking to ensure that the information provided in the booking is true and correct at the time of booking and the delegate warrants to TSBE it is authorised to make the booking.

TRAVEL DOCUMENTS / VISAS: According to the smarttraveller.gov.au, the US has strict entry requirements for both tourists and transit passengers. US authorities will not allow you to enter the country if you do not comply. If you are visiting the US for less than 90 days, you may be eligible to apply for an Electronic System for Travel Authorization (ESTA) and then enter under the Visa Waiver Program, if you satisfy the applicable conditions. Otherwise, you will need to get a visa before you travel. Visa and other entry and exit conditions can change at short notice, including currency, customs and quarantine rules. Please check your eligibility on smarttraveller. gov.au and contact an embassy or consulate of the United States for the latest details that are specific to you. If you plan on travelling to another country, please check visa and entry requirements for each other country.

USA ESTA: Delegates are obliged to comply with US entry and transit requirements and will be required to complete an official ESTA application prior to delegation, online through the U.S. Customs and Border Protection website. You must show a copy of your ESTA and supporting documents to the relevant US officials when travelling to the U.S.

PASSPORTS: Delegates will require a current passport with 6 months validity beyond the date of return. Passport renewals can be done online through the Australian Passport Office and passport identification photos can be taken at selected Australia Post locations. You are responsible for ensuring your passport is valid for the Tour.

TRAVEL INSURANCE: Travel insurance is highly recommended for this Tour. You are responsible for your own travel insurance. Travel insurance assistance is available through local travel agencies such as Hello World and Flight Centre, insurance brokers or through participating banks and independent insurance providers. TSBE is not liable for delegates who do not take out or maintain appropriate travel insurance.

CANCELLATIONS: If you wish to cancel your booking, you must email TSBE.
