a. Provide an overview of how the proposed activities align with the Industry Growth Centres Initiative and other government programs

To 31/10/19 SQ Export Hub activities have focused on the key activities as listed above. The priority has been to lay down a firm foundation for the program and develop a suite of service offerings to able to be implemented from the commencement of 2020.

Part of this foundation work has been to gain an understanding of how the SQ Export Hub can align and support the work of our partner Growth Centres FIAL and NERA and our community of key stakeholders including Government both State and Federal. TSBE sees advantages in being closely aligned and building strong working relationship with this network to benefit and provide greater opportunities for the delivery of services through the Hub and to the region.

Given that the SQ Export Hub has been working on brand, marketing and promotional activities, consolidation of alignment with Growth Centre / stakeholder activities and programs will commence in 2020. Please refer the SME Export Hub Activities Report for activities to date.

During 2020 it is planned that interactions with Growth Centres, stakeholders and Government programs will cover:

- Alignment with mutually beneficial programs e.g. trade missions, seminar programs and conference participations, Grant / Funding opportunities for exporters
- The sharing of information and imparting information about regional strengths, issues and challenges which could benefit national networks supported by Growth Centres e.g. barriers to export, logistics, strengths and capabilities
- International exposure provides an excellent opportunity for the SQ Export Hub, Growth Centres and Stakeholders to work together. Events would include supporting each other with international conferences, seminars, in and out bound buyer missions and trade exhibitions e.g. NERA with the APPEA 2020 Conference in Perth in May (https://www.appeaconference.com.au) and Austrade/FIAL supported trade missions.
- Innovation provides a platform for international competitiveness and the SQ Export Hub is looking forward to working more closely with FIAL around their innovation and entrepreneurship programs. This is an identified area of need and demand in our region, particularly given the environmental conditions and progressive companies are looking at all avenues for support in this area. NERA will also play a strategic role in this space as it will innovation that will drive the competitiveness of our Oil and Gas companies globally.
- Given environmental conditions, the importance of supply chain capabilities for both sectors
 are identified needs. Both FIAL and NERA could play pivotal roles in providing national and
 international linkages to build supply, capacity and sustainability.
