

## **South Korea Trade Mission – Expression of Interest**

**Building International Relations between Southern Regional Queensland and Korea** 

The Toowoomba and Surat Basin Enterprise (TSBE) was successful in receiving funding for a trade mission to Korea, under the Department of Foreign Affairs and Trade (DFAT) International Relations Grant Program. Aligning to the Australia-Korea Foundation's priority area of progressing trade and commerce between Australia and Korea, TSBE is calling on all agrifood and agtech interested in the Korean market to apply to participate.

TSBE Food Leaders Australia is leading a seven-day trade mission to the Republic of Korea to explore trade and commerce opportunities. The aim of this trip is to give regional agrifood and agtech businesses the opportunity to experience in market buyer matching, site visits and networking while progressing commercial industry outcomes.

The Republic of Korea (ROK) is Australia's third largest export market, largely due to the county's dependence on imported energy, resources and agriculture, and Australia's fourth largest two-way trading partner. Despite Korea already establishing itself as a major importer of Australian products, Austrade has identified an untapped potential for businesses in the ROK in other sectors. In 2023, in market consumer research has noted that ROK customers are continuing to demand high quality food, beverage and consumer goods. Furthermore, Australian technology and services are also in demand. With an aging population, Korea's microfarms are requiring agtech solutions that can improve the efficiencies of day-to-day practices.

The Korea-Australia Free Trade Agreement (KAFTA) strengthens opportunities by improving market access for Australian companies, creating new services opportunities, whilst safeguarding Australia's competitiveness in this large market.

As part of this trip, TSBE will be hosting a networking event in Seoul that will bring local industry together with the delegation. Prior to the trade mission, TSBE will be facilitating a market insights and trade readiness session which will provide participants with insights on consumer trends, the business landscape, requirements for export and post COVID-19 market update by in market specialists.
